# US economic growth, rupee fall to boost Indian exports: Assocham

India's exports hold a promising outlook with the US economy growing at its best in four years, coupled with the rupee depreciation leading to enhanced net revenue realisations, according to a report by Assocham. The US emerged as the top export destination for India, with USD 47.9 billion worth of shipments in the last fiscal ended March, followed by the UAE and Hong Kong, the commerce ministry data showed. The US economic growth accelerated by 4.2 per cent in the second guarter of this year, its fastest pace in about four years despite the ongoing tariff war with China. "The US accounted for about a good chunk of 16 per cent of India's total merchandise exports of USD 303 billion in the fiscal 2017-18 with the annual growth of 13.42 per cent, the report said. It is the largest market for Indian exports, both for merchandise and even services.

# Government of India and the Asian Development Bank (ADB) sign US\$ 150 million loan agreement to support India's First Global Skills Park in State of Madhya Pradesh

Asian Development Bank (ADB) and the Government of India signed a \$150 million LoanAgreement in New Delhi todayto establish a Global Skills Park (GSP) in Madhya Pradesh, the First Multi-Skills Park in India, to enhance the quality of Technical and Vocational Education And Training (TVET) System in the State and create a more skilled workforce. The signatories to the Madhya Pradesh Skills Development Project were Mr. Sameer Kumar Khare, Additional Secretary, Department of Economic Affairs (Fund Bank and ADB), Ministryof Finance, who signed on behalf of the Government of India, and Mr. Kenichi Yokoyama, Country Director of ADB's India Resident Mission, who signed for ADB.

Speaking on the occasion, Mr Khare said that the Project will help improve the quality and relevance of the State's TVET programs and will help impart advanced job-ready skills training of international standards that can meet the employment needs of the State's emerging sectors.

## India continues to be world's largest BPM base, generated US\$ 32.5 bn revenue

body Nasscom Thursday said India continues to be the largest BPM (business process management) base in the world, generating close to USD 32.5 billion in revenue with an employee strength of 1.2 million. The Indian BPM industry is estimated to now account for over 37 per cent share in global sourcing and is witnessing a 1.7X revenue growth. This is set to grow from USD 154 billion to a projected USD 167 billion in FY18, an increase of almost 8 per cent, Nasscom said in a statement. Nasscom, which hosted its BPM Summit 2018 in highlighted that the industry is taking advantage of emerging technologies such as Robotic process automation (RPA), artificial intelligence (AI), digital communications, Internet of Things (IoT), cognitive computing more, to improve profitability, collaboration and competitiveness.

# India set to become engine of world's growth, says PM Narendra Modi

Prime Minister Narendra Modi said on October 8 that India has emerged as the best destination for investment in the world. At the inauguration of the "Uttarakhand Investors Summit" here, the Prime Minister said more than 10,000 measures had been taken by the Centre and the state governments to make the environment conducive for investments. Skirting the issue of the falling rupee, Modi said India is all set to become the main engine of the world's growth. India has climbed 42 points in the ease of doing business rankings, he said,

adding the infrastructure in the country is also strengthening. "We are working to provide air connectivity to all tier-II and tier-III cities in the country for which we are building 100 new airports and helipads," he said.

The government is developing more than 100 national waterways and modernising 400 railway stations. All these steps are being taken to strengthen the economy of the country, he said.

## India and US bilateral trade rises 119% since 2007 at US\$ 126.2 billion

Bilateral trade of goods and services between India and the US has gone up by 119 per cent since 2007, touching \$126.2 billion, according to the data collated by the office of the United States Trade Representative (USTR). According to the data, exports were valued at \$49.4 billion and imports were worth \$76.7 billion. The US goods and services trade deficit with India was \$27.3 billion in 2017. The data comes at a time when the two nations are locked in a trade war. "India is our ninth largest goods trading partner with \$74.3 billion in total (two-way) goods trade during 2017. Goods exports totaled \$25.7 billion and goods imports totaled at \$48.6 billion. The US goods trade deficit with India was \$22.9 billion in 2017," said USTR on its website.

Proposed new industrial policy to be approved soonThe new industrial policy, which aims at promoting manufacturing, attracting investments and creating jobs, is ready and will soon be approved by the Union Cabinet, Commerce and Industry Minister Suresh Prabhu said Thursday. He said the policy is in sync with the challenges and opportunities to be brought up by the 'fourth industrial revolution'. With technologies in the manufacturing sector, the world is talking about the fourth industrial revolution. It includes artificial intelligence, robotics, internet of things, block chain and machine learning. India too is gearing itself to use these modern technologies to boost its manufacturing sector and increase its share in the country's gross domestic product (GDP).

The Department of Industrial Policy and Promotion (DIPP), under the commerce and industry ministry, in August last year floated a draft industrial policy with an aim to create jobs for the next two decades, promote foreign technology transfer and attract USD 100 billion FDI annually.

## Tata Motors' JLR opens manufacturing plant in Slovakia

Tata Motors-owned Jaguar Land Rover on Thursday announced the opening of its new state-of-the-art USD 1.6 billion manufacturing facility in Slovakia, a first for a British automotive brand setting up in the central European country. JLR said its investment is expected to lead to an annual production of 100,000 cars at the new Slovak plant by 2020.

He hailed the move as the start of a new era in manufacturing for the luxury car brands and the culmination of four years of planning.

The UK-based company, which was acquired by the Tata Group a decade ago, said the creation of new international factories allows JLR to "offer customers even more exciting new models, protect against currency fluctuations and support a globally competitive business".


On 12 october, Commemorative Stamps presented by Indian Ambassador to the Czech Minister of Culture.
