#### India's GDP grows at 8.2 per cent in 2018-19 Q1

India's economy grew at an impressive 8.2 per cent in the first quarter of 2018-19 financial year ending June 30 on the back of a strong core performance and a healthy base. This jump ahead of national elections next year would help bolster the government amid a debate over its economic record versus that of its predecessor following the release of back-series data recently. This will also be factored in by the monetary policy committee at its next review scheduled for October 3-5. Key Highlights: This is the highest growth in two years and strongest since the first quarter of 2016. Sectors which registerd growth of over 7 per cent include manufacturing, electricity, gas, water supply & other utility services construction and public administration, defence and other services. ## India will be our largest R&D base in next 3 years.

Premium smartphone maker OnePlus is betting on the engineering talent pool in the country to drive innovation and expects India to become its largest research and development (R&D) base in the next three years. The company, which has recently set up its R&D centre in Hyderabad, has similar facilities in Shenzhen, Taiwan and the US. It has about 700 people globally working in its R&D teams. The idea is to have a long-term approach, bringing the best of talent and training them and have them work with us over the long term.... We anticipate that India will be our largest R&D base in three or more years, OnePlus co-founder and CEO Pete Lau told PTI.

He added that the company is engaging with the top engineering colleges like IITs to scout for talent. The India R&D team has under 100 people currently. The focus, Lau said, is on using software and technologies like artificial intelligence to make a global impact. Lau highlighted that there is "significant untapped potential" in the Indian market as the premium segment accounts for about 4-5 per cent of the overall smartphone shipment. According to

research firm IDC, smartphone shipments in India touched an all-time high of 42.6 million units in July-September 2018 quarter, registering a year-on-year growth of 9.1 per cent.

## IndiGrid launches roadshows to raise fresh capital up to ₹3,000 crore

IndiGrid currently owns 10 independent revenue-generating elements. India Grid Trust (IndiGrid), an infrastructure investment trust (InvIT) sponsored by Sterlite Power Grid Ventures Ltd, has started roadshows to raise ₹2,500-3,000 crore in fresh capital, said three people aware of the development. IndiGrid currently owns 10 independent revenuegenerating assets, including eight transmission lines of 1,936 circuit km and two substations of 6,000 MVA capacity. InvITs are trusts that manage income-generating infrastructure assets, offering investors regular yields and a liquid way to invest in infrastructure projects. In September, IndiGrid had bought Patran Transmission Co. Ltd, its first third-party acquisition, for ₹232 crore. The acquisition was done through internal accruals and a debt issuance of ₹250 crore. In 2017, it had acquired three power transmission assets from Sterlite Power for ₹1,490 crore.

# The Government of India and ADB sign a \$31 Million Loan Agreement to develop Tourism and boost Jobs in Tamil Nadu

The Government of India and the Asian Development Bank (ADB) today signed in New Delhi a Loan Agreement for \$31 million to buildup the State Tourism Industry and boost visitor arrivals. The signatories to the tranche 4 loan for Infrastructure Development Investment Program for Tourism (IDIPT) were Mr. Sameer Kumar Khare, Additional Secretary (Fund Bank and ADB), Department of Economic Affairs, Ministry of Finance, who signed for the Government of India, and Mr. Kenichi Yokoyama, Country Director for ADB in India, who signed for ADB. After signing the agreement, Mr Khare said that the Project is expected to improve the tourism infrastructure in Tamil Nadu and also help the State in preserving the natural and cultural heritage. The activities under the project would also boost economic opportunities for the local people, he added. This will be achieved through

developing and preserving sites of natural and cultural heritage, and building connectivity, capacity, and infrastructure around State tourist sites.

#### India's exports on the rise

India's exports clocked highest growth in last 6 years. Sector specific interventions, focused promotion initiatives, transparency and quick resolution of issues have led to an impressive export growth of 14.76% in 2017-18 (Oct-Sept) over previous year. The Department of Commerce is making all efforts to diversify India's export basket region wise and commodity wise. Free Trade Agreements (FTAs) are a means of correcting India's balance of trade. With the USA bilateral negotiations are on and with China, India has held three interministerial delegations in June, August and November 2018 led by the Department of Commerce to pursue market access issues with Ministry of Commerce China (MOFCOM). General Administration of Custom China (GACC) has approved total 24 Indian rice mills for exporting non-basmati rice to China and the first consignment of 100 tonnes of white rice (5% broken) was shipped on 28.09.2018 and 30.09.2018. In October 2018 another 23 tonnes of rice was exported to China followed by 260 tonnes in November 2018.

# Several steps have been taken to promote quality education in the country - Shri Prakash Javadekar

Union Minister for HRD Shri Prakash Javadekar has said that the government is committed to increase quality education in the country right from primary education to higher education. Mr Javadekar was speaking at the national Conference on 'Positioning India on the Global Education Map' in New Delhi today. In higher education, we have taken tremendous steps to improve college education, for this we are making accreditation process more scientific and tough. Government wants to increase the strength of NBA and NAAC so that more number of institutions can be accredited, the Minister added. The Union Minister said that teacher is the most important component to increase quality education in the colleges and universities. He said that attendance should increase in the classroom because of teacher's skills not because of the infrastructure of the college. He further said that we are lacking good teachers in the institutions because good people are not becoming teachers. Graded autonomy is another major step of the government to boost quality education in the country, the Minister said. Shri Javadekar explained that the universities will remain within the ambit of UGC but will have the freedom to start new courses, off campus centers, skill development courses, research parks and any other new academic programs. They will also have the freedom to hire foreign faculty, enroll foreign students, give incentive based emoluments to the faculty, enter into academic collaborations and run open distance learning programmes.

#### Gujarat is the best place for startups

Gujarat topped the first ever startup ranking of states by the Department of Industrial Policy and Promotion, ahead of states such as Karnataka, known for their startup culture. A total of 27 states and three union territories participated in the exercise. The DIPP consulted stakeholders of the startup ecosystem and came up with seven key reform areas as the basis of the ranking. An online portal was launched to help states submit their initiatives across the reform areas. The "top performers" include Karnataka, Kerala, Odisha and Rajasthan, while states such as Andhra Pradesh, Bihar, Chhattisgarh, Madhya Pradesh and Telangana were put in the "leaders" category.

## Manufacturing sector posts strong sales growth in O2

Manufacturing sector, particularly textile and iron and steel segments, maintained its pace of sales growth in the second quarter of 2018-19 as compared to the year-ago period, the RBI stated. Demand condition in the manufacturing sector "maintained its pace in the September quarter 2018-19 as reflected in strong sales growth (year-on-year)", as per the RBI analysis of 2,700 listed private sector non-financial companies. "The manufacturing sector sales growth was mainly supported by robust demand conditions in chemical and chemical products, iron and steel, and petroleum products industries coupled with significant improvement recorded by textile industry," the RBI said. The central bank said

heavy moderation was seen in the sales growth of motor vehicles and other transport equipment, driven in part by a large adverse base effect, and pharmaceutical and medicine industries. The RBI said companies in manufacturing sector posted a net profit of Rs 47,100 crore in the reported quarter, up 29.4 per cent from the same period last year. The data is based on abridged financial results of 1,734 companies in the manufacturing sector.

# Khelo India Scheme to achieve mass participation and promotion of excellence in sports

The revamped Khelo India Scheme was launched during the financial year 2017-18 with a view to achieving the twin objectives of mass participation and promotion of excellence in sports. The vision of the revamped Khelo India is to infuse sports culture and achieve sporting excellence in the country. The mission as stated in the revamped scheme is to encourage sports for all thus allowing the population across gender and all age groups to harness the power of sports through its cross-cutting influence, namely, holistic development of children & youth, community development, integration, gender equality, healthy lifestyle, national pride and economic opportunities related to sports development. Under the Khelo India the identified sports talents will be given the option to join SAI National Sports Academies, State Sports Academies or Sports Academies established by private sector. Grants-in-aid will be provided for establishment, operation and maintenance of sports academies in respect of identified disciplines to Sports Authority of India, State Governments or to private sector or sports person under Public Private Partnership (PPP) mode for facilitating and supplementing Long Term Athlete Development (LTAD) programme (for 8 years).
