100-day agenda: Com min proposes major export promotion scheme to boost shipments

The commerce ministry prepared a 100day action plan as the new government took office on May 30. The plan includes a major export promotion scheme to ensure expeditious refund of central and state taxes and levies to boost shipments in the wake of global challenges at trade front. A new export promotion scheme has become necessary as the existing merchandise exports for India (MEIS) scheme is being opposed by the US in the World Trade Organisation (WTO), stating it is not in compliance with global trade norms. The new scheme could be named as Central and State Taxes and Levies Scheme. According the to proposal, the new scheme would ensure refund of all un-rebated central and state levies and taxes imposed on inputs that are consumed in exports of all sectors. Initiatives by Commerce and Industry Minister Suresh Prabhu has helped in taking exports to an all-time high of USD 331 billion in 2018-19. The ministry has also proposed to Introduce a WTO production-based compliant support scheme to increase outbound shipments.

The of Commerce Department consulting with all the concerned stakeholders to frame this scheme to promote high potential sectors electronics, telecom, hi-tech engineering, medical devices, pharmaceuticals, and textiles. technical Any government support which is subject to export performance becomes prohibited а subsidy under WTO norms. The ten-point action plan has also proposed the launch



of a new five-year foreign trade policy (2020-25) on September 1 this year and promote shipments of the services sector. The current policy will end in March 2020.

Commerce and Industry Minister reviews draft National Logistics Policy

Union Minister of Commerce and Industry & Railways, PiyushGoyal, reviewed the draft National Logistics Policy and the proposed action plan for implementation of the policy prepared by the Department of Logistics, Ministry of Commerce and Industry.

The draft National Logistics Policy has been prepared in consultation with the Ministries of Railways, Road Transport and Highways, Shipping and Aviation. Forty-six Partnering Government Agencies (PGAs) inputs were analyzed for consideration in the Policy. Commerce and Industry Minister in his opening remarks urged that all the four Ministries and their departments must leverage existing infrastructure to support each other in the logistics chain. This will not only help in maximizing existing infrastructure to support each other in the logistics chain.

This will not only help in maximizing capacity utilization but also reduce costs he added. PiyushGoyal directed that all four Ministries must work in coordination with each other so that the 14% logistics cost of India's GDP may be brought down to 9%. In the meeting all aspects of logistics related to railways, civil aviation, shipping and inland waterways, road transport, ropeways warehousing and cold chain were discussed in detail.

GST council to introduce new GST return system

Businesses will be able to use the new return filing forms under Goods and Services Tax (GST) on a trial basis for beginning months July, said. the government spelling out transition plan for the new tax return filing Currently, system. companies businesses have to file tax returns via GSTR3B or summary form and GSTR1, which entails details of outward supplies. The new system will comprise three forms -- GST ANX-1 that will capture details of outward supplies, GST ANX-2 which will be the purchase form and GST RET-1 which will be the final return form. While the new purchase and sales forms will be available for trial July-September, businesses will still have to file returns based on GSTR1 and GSTR3B. The new return form GST ANX -1 will be made compulsory October onwards, replacing GSTR1, the existing forms -- GSTR3B and GSTR1 -- will be phased out completely from January 2020.

20 lakh farmers expected to benefit as PMKSY expected to leverage investment of Rs 31,400 crore

Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) is expected to leverage investment of Rs 31,400 crore, handle of 334 lakh MT agro-produce valuing Rs 1,04,125 crore, benefit 20 lakh farmers and generate 5,30,500 direct/ indirect employment in the country by the year 2019-20. This was stated by Union Minister of State for Food Processing Industries Shri RameswarTeli. in the

Parliament. The Minister added that under following PMKSY schemes Parks; implemented: Mega Food Integrated Cold Chain and Value Addition Infrastructure; Creation / Expansion of Food Processing & Preservation Capacities: Infrastructure for processing Clusters; Creation Backward and Forward Linkages; Food Quality Safety and Assurance Infrastructure; and Human Resources and Institutions. He also stated that 100% FDI is permitted under the automatic route in food processing sector. 100% FDI is also allowed through Government approval route for retail trading, in respect of food products manufactured and/or produced in India. The sector has witnessed FDI equity inflow of US\$3.28 billion during April 2014 to March 2019. Seven FDI proposals for retail trading in food products have been approved amounting to about US\$ 705 million during 2017-18. Minister also informed steps/measures taken to boost the growth

of food processing sector in the country which are: creation of a special fund of Rs 2000 crores in National Bank for Agriculture and Rural Development (NABARD) to provide affordable credit to food processing industries, classification of food & agro-based processing units and cold chain as agricultural activity for Priority Sector Lending (PSL); lower Goods & Services Tax (GST) rates for products. of food exemption of income tax on profit for new food processing units, 100 percent income tax exemption from profit derived by FPOs having annual turnover of Rs.100 crore for activities such as postharvest value addition to agriculture, concessional import duty for plant and machinery under project imports benefit scheme, import duty exemption on import material under of raw advance authorization scheme etc.

Czech Post Releases Bapu@150 commemorative Postage Stamp

A commemorative postage stamp marking the 150th anniversary of the birth of Mahatma Gandhi was unveiled on 26 June, 2019 as a joint effort of Czech Post and the Embassy of India, Prague. The ceremony was held at the Embassy of India in Prague in the presence of Czech Post's Director General, Mr. Roman Knap and Her Excellency, Mrs. Narinder Chauhan, Ambassador of India to the Czech Republic, and attended by the stamp designer, Mr. Jan Kavan.

The stamp portrays Mahatma Gandhi with his hands folded in the conventional Hindu gesture of greeting and deep respect. The motif of the first day cover (FDC) is based on the non-violence symbol of circles referring to perfection and harmony. In the context of the non-violence symbol, the represent folded hands mutual cooperation. The stamp and FDC are commemorative accompanied by а handstamp depicting Gandhi's spectacles and the date of issuing the stamp. All three items were designed by Jan Kavan and the FDC was engraved by Bohumil šneider, according to Czech Post.

"On the occasion of the 150th anniversary of the birth of our Father of the Nation, we remember his greatness not only in India but also by celebrations and activities around the world to spread his teaching and philosophy of non-violence. Czech stamps have long been valued as most beautiful ones. I am therefore pleased that Mahatma Gandhi became the motif of one of them," said Her Excellency, Mrs.



peace. We are honoured to be able to contribute to the commemoration of his legacy by issuing this stamp. This is the first Czech commemorative stamp in the history remembering this person," said Roman Knap, Czech Post's Director General.

The Postal Security Printing Company in Prague printed 500,000 commemorative stamps by offset and 3,200 FDCs by recess printing from flat plates.

The Z stamp corresponds to stamps with the face value of CZK 41 used for priority International Ordinary Mail up to 50 g destined to non-European countries. The stamp is available at any dedicated philatelic counter, at certain post offices, or online via Czech Post's website.

An Energy Mission from the Czech Republic led by Mr Richard Hlavaty, Senior Director General of Foreign Economic Policies, Ministry of Industry and Trade visited the cities Uttarakhand, Manipur, Himachal Pradesh and Delhi from 25th - 28th June, along with four Czech companies dealing with turbines, hydro-mechanical water hydro-power equipments equipments, and metal fittings.
